REQUIREMENTS TO MAINTAIN A NPCAEF SCHOLARSHIP

- 1. The student must be attending or planning to attend an accredited institution of higher learning.
- 2. The student must be pursuing a course of study in an academic field which is related to the building, construction or precast concrete industry and have it so declared on transcripts.
- 3. The student must maintain a minimum of 12 credit hours per term of enrollment.
- 4. The student must submit a class schedule and copy of college acceptance prior to receipt of first installment. The student must submit a copy of his/her semester grade report before the next installment will be mailed.
- 5. Scholarship moneys awarded will be divided in half with each half being paid at the half year interval (August/September and December/January). The student will not receive payments until grades or transcripts have been received and all criteria have been met.
- 6. The student must meet a cumulative grade point average of 2.8 on a 4.0 grading schedule. Should the student fall below 2.8, the student will be placed on probation for one term, and the student will receive payment for the academic probation term. Should the student’s grades not meet the 2.8 average for two consecutive terms, the scholarship will be forfeited.
- 7. If the student follows an internship program prescribed by the academic institution and is part of the student’s academic curriculum, this will be considered a term of study and scholarship payment will be made.

HOW WILL SCHOLARSHIPS BE AWARDED?

All applicants will be reviewed, and scholarships will be awarded based on course of study relative to the application requirements, thoroughness of the completed application, scholastic standing, ACT/SAT scores, career goals and extracurricular activities.

HOW MAY APPLICANTS APPLY?

The completed application must be submitted to the Foundation office at: 10333 N. Meridian Street, Suite 272, Indianapolis, IN 46290.

The application and necessary attachments must meet the postmark deadline for consideration by the Foundation’s Board of Directors.

Applications will be reviewed by the Foundation Board of Directors and students will be notified by mail of the Board’s decisions.

WHO MAY APPLY?

Any high school student, high school graduate or current undergraduate may apply who will be enrolling full time in an academic institution for the year beginning in September following the date of application, and whose course of study is in an academic field related to the building, construction or precast concrete industry.

The academic institution may be either a four year college or a community college with a recognized related course of study. Scholarships will not exceed four years and are awarded in the amount of \$1,000 per academic year.

WHAT MUST ACCOMPANY THE APPLICATION?

To guarantee the application will be reviewed by the Educational Foundation Board of Directors, the following materials must be included with the application:

- 1. A transcript of high school grades and/or college grades (if applicable) through the latest grading period prior to the date of application. The high school transcript must include ACT/SAT scores and class standing.
- 2. A letter of recommendation from a member of the high school or college (if applicable) faculty.
- 3. A letter of recommendation from an NPCA member considered to be in good standing.
